

**2nd Final Notice of Recusancy And
Notice of Intent To File FERPA Violations
Grievance With Family Compliance Office**

Dear Ms. Jordan,

This is a notice to inform you that as of the close of business 1-18-05, you are not in compliance with the Directive from Superintendent Dr. Donald Henderson dated January 13, 2005 to Karl Brown, Asst. Superintendent, Dr. Jerry Welch, Dir. of Student Activities and Don Booth, Principle, Fuller Middle School.

Dr. Henderson's Directive states that he is "directing all school district personnel...who have had written correspondence addressed to them from Ms. Stacey Goodwin regarding her daughter respond to her in writing by the close of business on January 18, 2005 since January 17 is a holiday. I also request a copy of said responses be sent to my office."

Additionally, you are in gross violation of my family's right to an equitable education and due process among many other violations through your questionable cooperations. I have postponed many rightful actions against all of the various obstructionists and violator's of my children's rights as it pertains to the FMS Gang Cover-up, as a basic courtesy to the PCSSD Board Members. As of January 11, 2005 Board Meeting, per DOE procedures, my obligations of said local process' have been fulfilled.

Mr. Karl Brown and his employer, the PCSSD Board no longer enjoy such broad courtesy's by actions of said Asst. Superintendent and neither he nor yourself enjoy such benefits on their accord any longer. You were quick to state how you would "handle" my child when I'm not around to monitor you. It is now demanded that you explain your verbal decision statements or offer your immediate resignation so that someone qualified and responsive may fill your shoes. Parents will no longer be subjected to your flagrant violations of their hard fought FERPA protections.

This School District does not garner the confidence of it's patron's by allowing you, a contracted administrator to absolutely refuse to explain why you have eagerly taken an active role in actions that have had direct effects upon my child and then further enjoy monetary benefits that my various taxes have contributed to your personal and non-responsive coffers. I rightfully perceive your various actions as fraudulent at the end of the day and outright objectionable to myself. You are "holding down" a job position at FMS and blatantly refusing to serve all of your patrons equitably as you are compelled to under Federal Laws and the most basic standards of behavior.

You are not serving my children's interests and they are not going to suffer from your inferior service any longer than they must, of this I am resolute ma'am.

Please be aware that a formal Federal Grievance will be filed against yourself, Ms. Moore, Mr. Abbott, Sherman Whitfield, Donald Booth and Asst. Superintendent Karl Brown specifically and the PCSSD Board on all of your regards generally, at the Family Policy Compliance Office in Washington D.C. of which I shall be personally filing within 14 days in said D.C. office. If you comply with my request at this point, it will not cause me to abandon my complaint, but may mitigate the rightful and vigorous nature of my sanction requests. Contrary to the words that Assistant Superintendent Karl Brown shared with me on speaker phone on 1-14-05, the safety of my children is *never* a “game” to me, not yesterday, tomorrow or TODAY.
