REQUEST FOR ADMINISTRATIVE EXPLANATION OR P/T CONFERENCE

Dear Mr. Whitfield,

I am formally requesting that you either explain your position in writing or schedule a P/T Conference to address the following concerns that I have regarding your activities and/or lack of as they pertain to the physical and emotional safety of my daughter Serenity.

As you are well aware, you were addressed by myself and Serenity's Uncle (please refer to the filed police reports) regarding your lack of actions as we ALL witnessed a gang member that had ALREADY committed a felony assault against my daughter, walk directly up to Serenity in YOUR presence and attempted to physically intimidate Serenity in the presence of other fellow gang members standing right next to you.

As I am a former employee of Fuller I have overheard Administrators frequently reply, "we'll just let their peers deal with them". Is this what you considered yourself doing by refusing to protect my daughter from gang intimidations that you are a witness to? Why did you outright refuse to take mandated actions? Further, why did you tersely respond by stating "we have a process, take your daughter home, SIR- take your daughter home"? What does that "process" have to do with blatant rule and criminal violations committed under your very nose? Are you prepared to claim NOT to see what was less than 3 feet in front of you? If so, why did you not see it or investigate the matter, being full aware in advance of the violence committed against my daughter within your school, upon your bus and off of the bus as the majority of the children got off at the wrong bus stop to witness my only daughter being violently assaulted by two gang members of C.A.S.H., namely Shaneka Cloud & Sholanda Gilliam. There were additional gang members that refused to participate because they indicated that they were afraid of the consequences. They further indicated that they were under extreme pressure from both Sholanda & Shaneka to join in the violence as you were made aware earlier when I was forced to withdraw my children because of these safety issues. Why have you been dragging your feet and further extending the dangerous and inhospitable environment of my daughter, by encouraging gang members to crime by making it *outright* and *obvious* that you will and in a documented manner have NOT done anything as they have literally taken over your school?

Again, you are welcomed to respond in writing. If this is not possible for you, then please immediately schedule said parent/teacher conference so that this matter may be addressed within the “process” that you so repeatedly speak about. I will return at the end of the school day for your written response or my appointment date for Parent/Teacher Conference. Please be prepared for all meetings to be audio taped.
